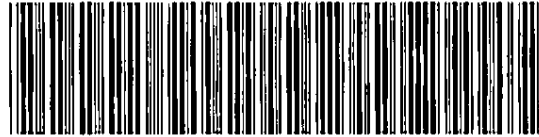

Applied them. Shana Conti is supposed to be the AMBR and John Conti Jr. is the MGR.


