**ARTICLES OF ORGANIZATION
OF
RICHARD S SAMUELS MD, PLLC**

The undersigned, Richard S Samuels, MD, a natural person competent to contract and member of RICHARD S SAMUELS MD, PLLC, hereby presents these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapters 621 and 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the professional limited liability company is RICHARD S SAMUELS MD, PLLC. This professional limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and initial principal address of the Company is 1204 Mary Lou Lane, Gulf Breeze, Florida 32563. The Company's mailing address and principal office may hereafter be at such other place or places as its member or members from time to time may determine.

ARTICLE III - PURPOSES AND POWERS

This Company is organized for the purpose of providing professional medical services and for any other legal and lawful purpose for which a professional limited liability company may be organized and shall have all powers and rights which a professional limited liability company may exercise under the Professional Service Corporation and Limited Liability Company Act and the Revised Limited Liability Company Act as such Acts presently exist or as they may hereafter be amended.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be effective on February 10, 2022 and the Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Company is 1204 Mary Lou Lane, Gulf Breeze, Florida 32563, and the name of the initial registered agent of the Company at that address is Richard S Samuels, MD.


ARTICLE VI - MANAGEMENT


