# ARTICLES OF ORGANIZATION OF LCF HATCH WELLINGTON, LLC

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Organization for the purpose of creating a limited liability company under the laws of the State of Florida.

#### **ARTICLE I**
