**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby make acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

**ARTICLE II**

**PURPOSES AND POWERS**


