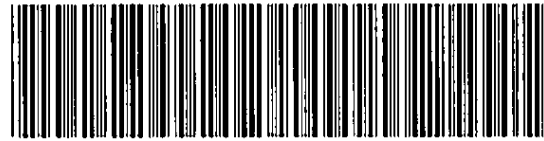





**ARTICLES OF ORGANIZATION  
OF

The undersigned hereby executes these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

**ARTICLE I**

**Name**

The authority, and duties of the Manager shall be as set forth in the Operating Agreement of the Limited Liability Company. #### ARTICLE V

##### Operating Agreement

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
