The mailing address and street address of the principal office of the Company shall be 1455 Railhead Boulevard, Unit 10, Naples, Florida 34110.

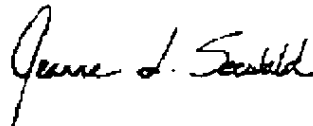
ARTICLE III -- REGISTERED AGENT

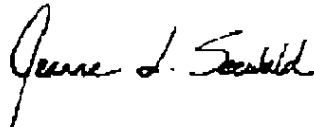
