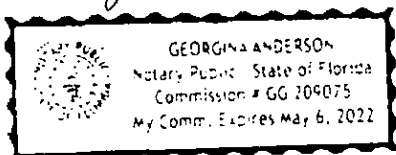
On 11/15/2021 we filed for Voluntary Dissolution for the LLC noted above.
