**ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION
MID-ATLANTIC AVIATION III, LLC**

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of Mid-Atlantic Aviation III, LLC, a Florida limited liability company (the "Company"), are hereby amended as follows:
