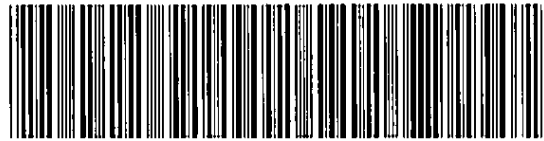

The name of the Company is "ATLANTIC CARIBBEAN SHIPPING, LLC." The Company shall be manager-managed.


