**ARTICLES OF ORGANIZATION  
OF  
BROWNME BOOKS, LLC  
A FLORIDA LIMITED LIABILITY CORPORATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the Limited Liability Company shall be: Brownme Books, LLC ("Company")

**ARTICLE II - ADDRESS**

The principal place of business of the Company in Florida shall be 2746 Carrington Lakes Blvd., Cantonment, Florida 32533 and the mailing address shall be the same.

**ARTICLE III – EFFECTIVE DATE**

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

**ARTICLE IV – DURATION**

Subject to the provisions of Article 8, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved pursuant to its Operating Agreement.

**ARTICLE V – PURPOSE AND POWERS**

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

**ARTICLE VI - MANAGEMENT**

The Company shall be managed by a manager or manager(s) in accordance with regulations adopted by the member(s) for the management of the business and affairs of the Company. These regulations may contain provisions for the regulation and management of the affairs of

the Company not inconsistent with law or these Articles of Organization. The names of all such manager(s) who is/are to serve as manager(s) is/are:

whose mailing addresses shall be the same as the principal office of the Company.

#### ARTICLE VII – ADMISSION OF ADDITIONAL MEMBERS

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be: Additional members may be admitted only as unanimously agreed upon by the Members as set forth in the Operating Agreement. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have right to participate in the management of the business and affairs of the Company or become a member unless all the other member(s) of the Company other than the member proposing to dispose of his or her interest approve the proposed transfer by unanimous written consent.

#### ARTICLE VIII – REGISTERED AGENT

The initial address of the registered office of this Company is 2746 Carrington Lakes Blvd., Cantonment, Florida 32533. The name and address of the registered agent of this Company is Erica Adams – Brown, 2746 Carrington Lakes Blvd., Cantonment, Florida 32533.

#### ARTICLE IX – TERMINATION OF EXISTENCE

The company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolutions of a member or manager, or upon occurrence of any event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least one remaining member.

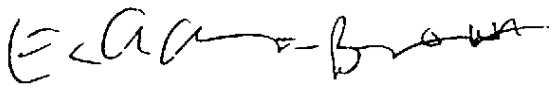
