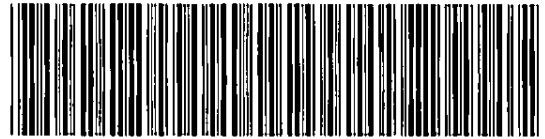

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
DICOMKT LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Amended and Restated Articles of Organization (the "Articles"), which amend and restate the Company's initial Articles of Organization filed on February 23, 2022.

ARTICLE I. NAME

The name of the limited liability company is DiCoMkt LLC (the "Company").

ARTICLE II. MAILING AND STREET ADDRESS

The mailing address and street address of the principal office of the Company shall be 413 Blue Road, Coral Gables, Florida 33146.


ARTICLE III. REGISTERED AGENT AND OFFICE
