AMENDED AND RESTATED ARTICLES OF ORGANIZATION

SECRETARY OF STATE The undersigned, for the purpose of forming a limited liability company under Incutation SEE. FL Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Amended and Restated Articles of Organization (the "Articles"), which amend and restate the Company's initial Articles of Organization filed on February 23, 2022, as amended by the Company's Amended and Restated Articles of Organization filed on March 1, 2022.

ARTICLE I. NAME
