## ARTICLES OF ORGANIZATION OF CREP OASIS FEE OWNER 2 LLC

The undersigned, being a duly authorized person of the Member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

### **ARTICLE I. NAME**
