ARTICLES OF ORGANIZATION OF QUINTANA TAX, PLLC

The undersigned, for the purpose of forming a professional limited liability company under the Florida Revised Limited Liability Company Act of the State of Florida pursuant to Chapter 605 of the Florida Statutes, and the Professional Service Corporations and Limited Liability Companies Act of the State of Florida pursuant to Chapter 621 of the Florida Statutes hereby makes, acknowledges, and files the following Articles of Organization providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

ARTICLE I NAME

The name of the professional limited liability company shall be QUINTANA TAX, PLLC (the "Company").

ARTICLE II MEMBERS

The Company shall have one or more members (the "Members").

ARTICLE III MAILING ADDRESS

The mailing address for the Company shall be 2100 Salzedo Street, Suite 200, Coral Gables, Florida 33134.

ARTICLE IV INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of the Company is 2100 Salzedo Street, Suite 200, Coral Gables, Florida 33134 and the initial registered agent is Brian A. Quintana.

ARTICLE V PURPOSES AND POWERS

The general nature and purposes of business to be transacted, promoted and carried on by the Company are as follows:

A. To engage in every aspect of the practice of accounting and all its fields of specialization, as licensed and permitted by the Department of Professional Regulation, Division of Certified Public Accounting, Board of Accountancy, and as otherwise legally authorized within the State of Florida to render the same professional services.

B. To engage and render the professional services involved only through its members, managers, officers, agents and employees who shall be accountants (to the extent permitted by law and applicable rules and regulations) in good standing and duly licensed and as legally authorized within the State of Florida to

render the same professional services.

C. To engage in no other business other than the rendition of the professional services specified herein.

D. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

**ARTICLE VI
DURATION**

The term and duration of the Company shall be perpetual, unless terminated in accordance with the Operating Agreement of the Company or otherwise terminated in accordance with law.

**ARTICLE VII
STREET ADDRESS OF PRINCIPAL OFFICE**

The street address of the principal office of the Company shall be located at 2100 Salzedo Street, Suite 200, Coral Gables, Florida 33134, but it shall have the power and authority to establish branch offices at any other place or places as the Members may designate.

**ARTICLE VIII
MEMBERSHIP RESTRICTIONS**

Additional Members may be admitted to the Company in accordance with the Operating Agreement of the Company. Contributions required of new Members shall be determined as of their time of admission to the Company in accordance with the Operating Agreement of the Company. A Member's interest in the Company shall be considered personal property, notwithstanding the actual nature of the assets owned by the Company, and may not be sold or otherwise transferred except in strict accordance with the Operating Agreement of the Company.

**ARTICLE IX
MANAGEMENT**

All Company powers shall be exercised by or under the authority of, and the business and affairs of this Company shall be managed by one or more Managers. Accordingly, the Company is a Manager-managed limited liability company. The name of the initial Manager is Brian A. Quintana and his business address is 2100 Salzedo Street, Suite 200, Coral Gables, Florida 33134.




