

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes (2013) Chapter 605, as amended, from time to time, hereby makes acknowledges and files the following Articles of Organization.

ARTICLE I.

NAME

The name of the Limited Liability Company is Mother or Nation LLC.

DURATION

The Company shall exist perpetually. The existence of this limited liability company shall begin on the date of the filing of these Articles of Organization.

New members may only be admitted pursuant to the regulations of the Company. A member may transfer his, her, its interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless approved by a seventy (70%) percent vote at a duly constituted meeting of members entitled to vote.

ARTICLE V.

Within 90 days of the occurrence of any event which would terminate the continued membership of a member of the Company, including but not limited to death, retirement, resignations, expulsion, bankruptcy or dissolution of a member, the Company shall terminate unless (a) a majority of the voting interest of the remaining members shall have voted to continue the business or (b) upon the death of the sole member, the successor to the interest of the member shall have voted to continue the business, and further provided that the company shall at all times have no less than one member.

AMENDMENTS


The Articles of Organization of this Limited Liability Company may only be amended by the majority vote of the members.
