The undersigned, Robert Preston, competent to contract and an authorized representative of Triangle Factory, LLC, hereby presents these Articles of Organization as the Articles of Organization of Triangle Factory, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Triangle Factory, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."
