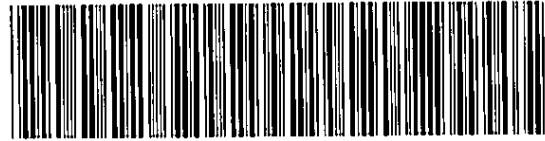

ARTICLES OF ORGANIZATION
OF

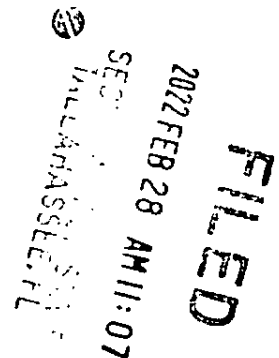

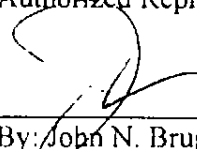

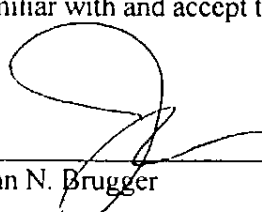
