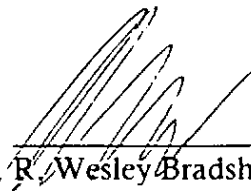

ARTICLE II - ADDRESS

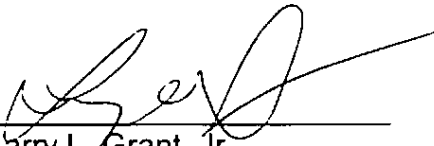

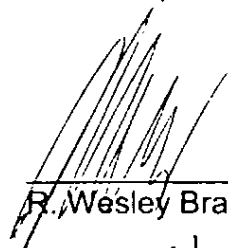
Certificate of Designation of Registered Agent and Registered Office
