3. The Company has approved and adopted the following amendment to the Articles of Organization:

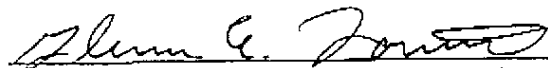
Article VI is hereby amended and restated in its entirety to read as follows:
