The Operating Agreement of the limited liability company (hereinafter the "Company") contains provisions regarding:

1. ARTICLE VII

The Interests of the current Members shall be evidenced by Certificates, which shall be issued by the corporation reflecting the percentage interest held by the Members.

ARTICLE VIII

The Operating Agreement between the Manager Member and the Company shall be adopted by the Members. Thereafter, the power to alter, amend, or repeal the Operating Agreement shall be vested in the Members of the Company in the manner set forth in the Operating Agreement; provided, however, that the consent of the Manager

Member shall be required before any amendment, alteration or repeal of the Operating Agreement.
