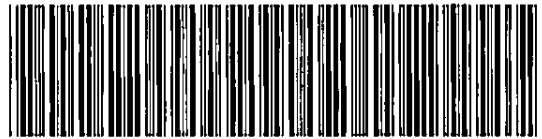

PURPOSE




