ARTICLE VI. PURPOSE


This Limited Liability Company is organized for the purpose of transacting any or all lawful business.

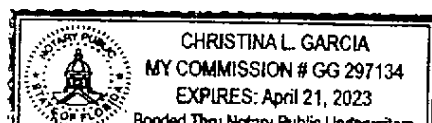
