### <u>ARTICLES OF ORGANIZATION</u> **OF** BLACK ACES TACTICAL SUPPLY, LLC

#### <u>ARTICLE I</u> NAME OF THE LIMITED LIABILITY COMPANY

## ARTICLE VII ADMISSION OF NEW MEMBERS
