**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION

**FIRST:** The name of the limited liability company is KCP Whitenight LLC (the "Company").


**SECOND:** The Articles of Organization of the Company were filed with the Florida Department of State on March 3, 2022, under Document Number L22000095153.
