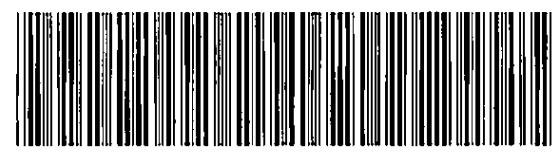

"The Company shall be managed by one or more Managers. The names and addresses of the initial Managers are:


