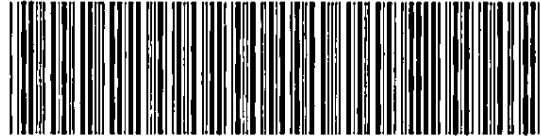

The name of the limited liability company is "Triple C Labs Management Holdings, LLC" (the "Company").


**ARTICLE II
