ARTICLES OF ORGANIZATION OF MOONFLOWER PRODUCTIONS, LLC.

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Revised Limited Liability Company Act (Florida Statutes Chapter 605).

ARTICLE I

Regulations: The members shall have the power to adopt, alter, amend, or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.


ARTICLE VII
