ARTICLE VII

Said Company is organized exclusively for charitable, educational, research, scientific purposes, and the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Institute for Music Business, LLC, is a career and technical education provider, and in addition operates or may operate a school, a publishing division, a division which distributes charitable merchandise, and other divisions which further the educational purposes of the LLC.

ARTICLE VIII

Upon the dissolution of the Company assets shall be distributed to one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Company is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE_IX

No part of the net earnings of the **Company** shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the **Company** shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Third Article.

ARTICLE X

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Company shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaigns on behalf of or in opposition to any candidate for a public office. Notwithstanding any other provision of these articles, the Company shall not carry on any other activities not permitted to be to be carried on (a) by a Company exempt from federal

income tax under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or (b) by a **Company**, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
