The street and mailing address of the principal office of the Company is: 1989 NW 88<sup>th</sup> Court, Suite 101, Doral, Florida 33172.


**ARTICLE III. REGISTERED OFFICE AND REGISTERED AGENT**


**ARTICLE IV. MANAGEMENT**
