The undersigned, Wade Howell, a natural person competent to contract and an authorized representative of HB South, LLC, hereby presents these Articles of Organization as the Articles of Organization of HB South, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

ARTICLE I - NAME
