**ARTICLES OF ORGANIZATION
OF
THRACE ST. HOLDINGS, LLC**

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Mailing Address and Purpose of Organization

The name of this limited liability company is Thrace St. Holdings, LLC (the "Company"). The Company's principal address is 2009 Thrace Street, Tampa, Florida 33605, and mailing address is P.O. Box 173447, Tampa, Florida 33672. The Company's initial registered agent is David M. Jeffries, whose address is 1227 N. Franklin Street, Tampa, Florida 33602. The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.

Duration of Existence




