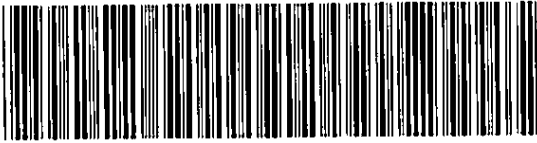


ARTICLE IX - MANAGEMENT

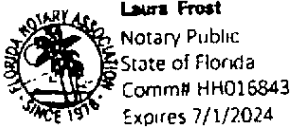

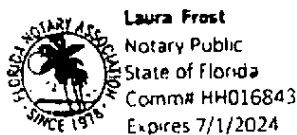
