



ARTICLES OF ORGANIZATION FOR PARBOYD, LLC, A FLORIDA LIMITED LIABILITY COMPANY



ARTICLE I. NAME

The name of the Limited Liability Company is "ParBoyd, LLC" (the "Company").

ARTICLE II. ADDRESS
