ARTICLES OF ORGANIZATION OF JK NELSON FLORIDA LLC

(a Florida limited liability company)

The undersigned, in forming a Florida limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605 of the Florida Statutes (the "Florida LLC Act"), hereby adopts the following Articles of Organization:

- 1. Name. The name of the limited liability company shall be "JK NELSON FLORIDA LLC", a Florida limited liability company (the "Company").
- 2. <u>Principal Office</u>. The mailing address and street address of the Company's principal office in the State of Florida are as follows:

3. Registered Address and Agent. The address of the Company's registered office, and the name of the Company's Registered Agent at such office, in the State of Florida are as follows:

4. Management. The Company shall be a manager-managed limited liability company; provided, however, that through an amendment to these Articles of Organization (the "Articles"), or through the Company's operating agreement as may be in effect from time to time (the "Operating Agreement"), the Company may elect to convert to a member-managed limited liability company.

As of the date of execution hereof, Jeffrey J. Nelson is the sole Manager of the Company.

- Limited Liability Company Interests. As of the date of execution hereof, the authorized equity capital of the Company shall consist of a single class of limited liability company interests which shall accord such relative rights, powers, entitlements, preferences, privileges, and duties as provided in the Florida LLC Act and the Operating Agreement. Through an amendment to these Articles, or pursuant to the Company's Operating Agreement, the Company may provide for the future creation of new or additional classes of limited liability company interests having such relative rights, powers, entitlements, preferences, privileges, and duties as the Company may determine, including, without limitation, rights, powers, entitlements, preferences, and privileges senior to the initial classes of limited liability company interests of the Company and/or the thenexisting classes of limited liability company interests of the Company.
 - 6. <u>Duration</u>. The Company shall not have a specific effective date of dissolution, and

its existence shall be perpetual in accordance with the terms and conditions of the Company's Operating Agreement.

7. <u>Effectiveness.</u> These Articles shall be effective as of the date registered by the Florida Department of State, Division of Corporations.
