The name of the Limited Liability Company is IGB Consultancy, LLC.


ARTICLE II - Address:

ARTICLE V – Membership Units:


The initial number of membership units in the Limited Liability Company shall be 1,000 of which 1,000 shall be initially distributed to the members in proportion to their percentage ownership.
