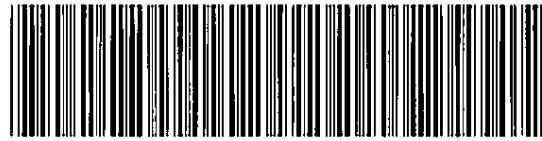



ARTICLE I - NAME
