The name and the Florida street address of the registered agent are C T Corporation System, 1200 South Pine Island Road, Plantation, FL 33324.

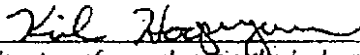
**ARTICLE 4

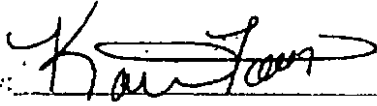
