ARTICLES OF ORGANIZATION FOR YODA ASSETS, LLC

ARTICLE I - NAME

The name of the Limited Liability Company is YODA ASSETS, LLC.

ARTICLE II - ADDRESS

ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

Likewise, there shall be no return of all or a portion of the contributed capital without the consent of Members owning one hundred (100%) percent of the Member Units of the Limited Liability Company.

ARTICLE IX - OFFICERS
