Pursuant to the provisions of Section 605.0202 of the Florida Revised Limited Liability Company Act, **6912 SOUTH ATLANTIC AVENUE, LLC** adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the limited liability company is 6912 South Atlantic Avenue, LLC (the "Company").
