- SECOND:** The Articles of Organization were filed on March 17, 2022 and assigned document number L22000111480.
- THIRD:** The date of the adoption of these Articles of Dissolution is 15 September 2022.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
