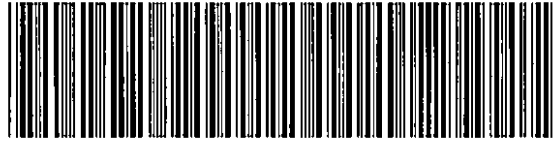

The mailing address and street address of the principal office of the Company shall be 1001 Brickell Bay Drive, Suite 3200, Miami, Florida 33131.


ARTICLE III. REGISTERED AGENT AND OFFICE


