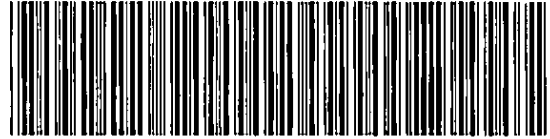

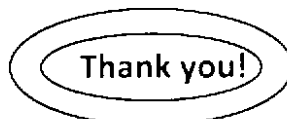

Management


