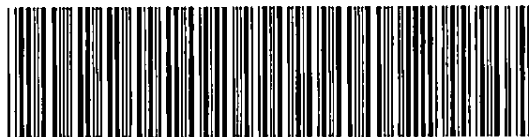

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF
FAIRWAY 4103, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Amended Articles of Organization.

ARTICLE ONE - NAME

The name of the limited liability company shall be FAIRWAY 4103, LLC (hereinafter the "Company.")

ARTICLE TWO - ADDRESS

The mailing address of the principal office of the Company shall be 1883 SW Crane Creek Avenue, Palm City, Florida 34990.

ARTICLE SEVEN - ADMISSION OF NEW MEMBERS

A member may transfer her or his interest in the Company as set forth in the regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of her or his interest approve of the proposed transfer by unanimous written consent.

ARTICLE EIGHT - PURPOSE

The purpose for which this Limited Liability Company is organized is any and all lawful business.

ARTICLE NINE - TERMINATION OF EXISTENCE

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all remaining members.

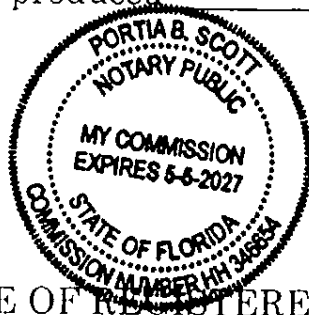
