

AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF FAIRWAY 6202, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Amended Articles of Organization.

ARTICLE ONE - NAME

The name of the limited liability company shall be FAIRWAY 6202, LLC (hereinafter the "Company.")
