ARTICLE I  
NAME; ADDRESS AND PLACE OF BUSINESS

The name of the Company shall be: AURORA GARDEN CARE, LLC

The address of the principal office and the mailing address of this Company shall be 12506 ASHDOWN DRIVE, ODESSA, FL 33556

ARTICLE II  
EFFECTIVE DATE AND DURATION; POWERS

The Company's effective date is the date of formation and its duration shall be perpetual.

The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes* (the "Act").
