

**ARTICLES OF MERGER OF TECHSTAR ELECTRONICS, INC.,
a Florida corporation, with and into
TECHSTAR, LLC, a Florida limited liability company**

Pursuant to Section 607.1105 of the Florida Business Corporation Act, as amended (the "Florida Business Corporation Act"), and Section 605.1025 of the Florida Revised Limited Liability Company Act, as amended (the "Florida LLC Act"), Techstar Electronics, Inc., a Florida corporation (the "Merging Corporation"), and Techstar, LLC, a Florida limited liability company (the "Surviving LLC"), hereby adopt the following Articles of Merger for the purpose of merging the Merging Corporation with and into the Surviving LLC.

1. The Merging Corporation shall be merged with and into the Surviving LLC, and the Surviving LLC shall be the surviving entity of the merger, pursuant to that certain Agreement and Plan of Merger by and between the parties dated effective as of December 31, 2022 (the "Plan of Merger").

2. The name of the surviving entity shall be "Techstar, LLC."

3. The Plan of Merger was properly approved, adopted, certified, executed and acknowledged by those shareholders of the Merging Corporation owning a majority voting interest in accordance with Section 607.1103 of the Florida Business Corporation Act, and by those members owning a majority voting interest of the Surviving LLC in accordance with Section 605.1021 of the Florida Revised Limited Liability Company Act.

4. This merger shall become effective as of December 31, 2022 pursuant to the filing of the Articles of Merger with the office of the Florida Secretary of State of Florida (the "Effective Date").

5. The executed Plan of Merger is on file at the principal place of business of the Surviving LLC, the address of which is 10850 NW 27th Street, Doral, Florida 33172.


