**STATEMENT OF CORRECTION
TO

Pursuant to the provisions of section 605.0209 Florida Statutes, this document is being submitted to correct the Articles of Organization of Small Batch Whiskey LLC:

FIRST: The name of this Florida limited liability company is SMALL BATCH WHISKEY LLC (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on March 24, 2022, and assigned Document Number L22000121755.

THIRD: Article 5 of the Articles of Organization incorrectly reflected the initial registered agent and registered office of the Company.

FOURTH: Article 5, as corrected, states as follows:
