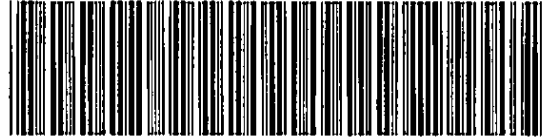

3. The name of the Florida limited liability company as set forth in the attached Articles of Organization is Wesley J. Madden, LLC (the "Converted Entity").

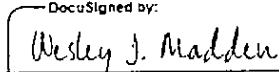

**ARTICLES OF ORGANIZATION
OF

The undersigned, Wesley J. Madden, a natural person competent to contract and an authorized representative of Wesley J. Madden, LLC, hereby presents these Articles of Organization as the Articles of Organization of Wesley J. Madden, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is Wesley J. Madden, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”
