The mailing address and street address of the principal office of the Company shall be 3030 Coral Way, Miami, Florida 33145.

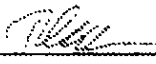

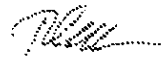
ARTICLE IV - MANAGEMENT
