The undersigned, for the purpose of forming a Limited Liability Company under the "Florida Revised Limited Liability Company Act," F.S. Chapter 605 (the "Act"), does hereby adopt the following Articles of Organization:

Article I

The name of the limited liability company is **Epic Coral Way GP LLC** (the "Company").

Article II

The principal place of business and mailing address of the Company shall be **2250 SW 3rd Avenue, Suite 500, Miami, FL 33129**.

Article III

The Company may transact any and all lawful business for which limited liability companies may be organized under the Florida Revised Limited Liability Company Act.

ARTICLE IV

In accordance with Section 605.0108(3) of the Act, the term of existence of the Company shall commence upon filing these articles of organization with the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved.

Article V

The Company shall be a manager managed company. The initial Manager of the Company is **Michael Abbassi**. The Operating Agreement may contain provision for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.


Article VII
